2. Review of an Ordinance to approve amendments (TA-18-001) to the City of Tucker Zoning Ordinance, including but not limited to density bonuses.

Chairwoman Cara Schroeder explained that the case would be heard in a 10/10/10 format, in which the applicant would have 10 minutes to present the case, the Community Council would have 10 minutes to discuss the case, and the public would have 10 minutes to speak.

Tim Lampkin, Planner, presented the changes to the City of Tucker Zoning Ordinance. The changes include revisions to Article 2, 3, 4, 5, 7, and 9. Changes include, but are not limited to, density bonuses, removing "Urban Single Family" from the City code and increasing the number of Community Council members from seven to nine.

Members of Community Council had questions about specific language in the text amendment which were answered by Tim Lampkin. There were also concerns about a lack of opportunities for moderate home pricing, the removal of Urban Single Family Detached, the number of Community Council members, workforce housing, and structured parking.

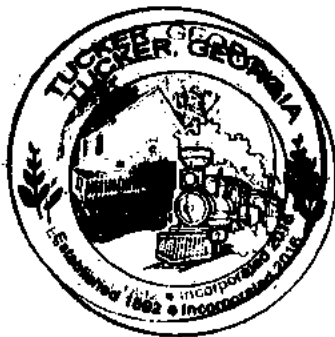
