~ **What is an Alcohol Catering License?**

- An Alcohol Catering License authorizes the provision of alcohol at events, functions or special event facilities outside of your business's current fixed location within the city.

~ **Review Process – Who can help me navigate the process?**

- Revenue Specialist: (678) 597-9040 or Licenses@tuckerga.gov
- Handle the intake and processing of all an alcohol catering license application. They can help you check if you already have a current alcohol beverage license.

~ **Prerequisite Licenses - Do I need any other licenses?**

- Yes, your business must first have a valid beverage license from the city to sell or otherwise dispense alcohol at a fixed location within Tucker in order to apply for an Alcohol Catering License. If you do not already have one, you will also need a Pouring Permit (which will require a Background Check). You must apply for a pouring permit through DeKalb County 3630 Camp Circle, Decatur, GA 30032

~ **Fees - What are the Fees?**

- The Administrative Fee is \$50 per application regardless of the type of alcohol (beer, wine, and/or liquor). Should you need a Background Check for a Pouring Permit the fee for the Background Check is \$50 and will be collected by DeKalb County.

~ **Multiple Events - Do I need an Alcohol Catering Permit for each Event?**

- Yes, O.C.G.A. 3-11-2 and 3-11-4 require separate applications for each off-premises catering permit.

~ **Sunday Sales - Do I need Sunday sales license for a catered event on Sunday?**

- Yes, your business must first have a valid Sunday sales license in order to apply for a Alcohol Catering License for a Sunday.

~ **Types of Alcohol – Does the type of alcohol served under a Resident Catering License need to match the type of alcohol for which my business has an existing license?**

- Yes, your business must first have a valid alcohol beverage license for the sale of each type of alcohol you intend to serve as with an Alcohol Catering License. That is, if your business processes a license only to sell malt beverages at your fixed location in the city you may only sell or serve malt beverages at the authorized catering event or function.

~ **Excise Taxes – Are excise taxes imposed on the sale of liquor with a Resident Catering License?**

- Yes, excise taxes are imposed upon the total of individual drinks of distilled spirits served by a resident caterer and shall be paid within 30 days after the conclusion of the catered event or function.
